

MEMORANDUM OF ASSOCIATION OF SRI SARASWATHI VIDYA PEETHAM

(Regd No.928 of 1977)

NAME : The Association shall be called Sri Saraswathi Vidya Peetham.

OFFICE : The Office of Sri Saraswathi Vidya Peetham hereinafter called 'Peetham' will be at Hyderabad - H.No. 6-3-597/A/7, Venkataraman Colony, Khairathabad, Hyderabad-500 004 or at any other place as decided by the Peetham, in accordance with the rules and regulations.

JURISDICTION: For proper administration and to facilitate official communication it is unanimously resolved to divide the Sri Saraswathi Vidya Peetham in to three parts, as Sri Saraswathi Vidya Peetham - Vijayawada and Sri Saraswathi Vidya Peetham - Ananthapur and parent body namely Sri Saraswathi Vidyapeetham Hyderabad Telangana State, allotting specific areas of operation to each of the body along with separate body to each of the units.

It is resolved to constitute the Sri Saraswathi Vidya Peetham - Vijayawada comprising districts of Srikakulam, Vijayanagaram, Vishakapatnam, East Godavari, West Godavari, Krishana, Guntur, Prakasham and Nellore as one unit with it's head quarters at Vijayawada here in after referred to as Sri Saraswathi Vidya Peetham - Vijayawada. Similarly for 4 districts of Rayalaseema namely Chittur, Ananthapur, Kadapa and Kurnool with it's head quarters at Ananthapur and here in after referred to as the Sri Saraswathi Vidya Peetham-Ananthapur.

The area of operation of the parent body i.e. *Sri Saraswathi Vidya Peetham Hyderabad will be for entire state of Telangana State.*

AIMS and OBJECTS :

- i) To run schools, colleges, nurseries, hostels and other institutions to promote education.
- ii) To impart discipline and cooperative endeavour in and amongst the students and teachers for building good character.
- iii) To undertake literary and allied activities such as conducting seminars, publishing of papers, books etc.
- iv) To inculcate a sense of patriotism in the younger generation and the society in general.

- v) To create spirit of duty, genius of leadership, self-reliance, hard work and application to social duty among the young generation.
- vi) To evolve and spread such an education system which would equip and create in the students, material and ethical skills and create a conducive atmosphere in the Society.
- viaa) To evolve and spread such an education system which would equip and create knowledge, skills, and attitudes in respect of material, ethical, and spiritual aspects of life in the students so as to create a harmonious atmosphere in the society.
- vii) For this purpose, the association may open and conduct schools which may be either
 - a) Samchalita (Self-run) or
 - b) Samlagna (Affiliated) or
 - c) Nirdesita (Aided and /or guided)
- viii) To affiliate itself with or give affiliation to the institutions or organizations having substantially similar aims, objects and also functions subject to conditions to be agreed mutually.
- ix) To do all other acts which the Peetham feels necessary to achieve the objectives of the Association.

INCOME, PROPERTY AND ITS USE

The income and property of the Association whatsoever derived shall be solely applied towards the promotion of aims and objects of the Association as set forth in the preceding clauses and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus, or otherwise by way of profits to the members of the Association, provided that nothing herein shall prevent payments in good faith, of remuneration to any officer or servant of the Association or to any other person in return for any services actually rendered to the Association and also to meet the expenses of travel or otherwise actually incurred for the benefit of the Association and in carrying out its programmes and activities.

DECLARATION

We, the following members, are desirous to form an Association under the above name and we respectively hold ourselves responsible to run the affairs of the Association according to the rules and regulations annexed hereto and the persons who signed in this Memorandum are desirous of getting the society registered under the Public Societies Registration Act No. I of 1350F.



RULES AND REGULATIONS OF SRI SARASWATHI VIDYA PEETHAM

1. DEFINITIONS

- a) **Peetham:** In interpretation of these rules unless there is any thing inconsistent with or repugnant to the subject or context, Peetham means, "Sri Saraswathi Vidya Peetham".
- a(a) **VIBHAG :-** A Vibhag is an administrative unit which may consist of two or more districts which shall have supervisory and co-ordinating responsibility over the districts in achieving the aims and objects of the peetham.
- b) **District:** District means geographical division made by the Peetham for its convenience.
- d) The Peetham for its effective functioning may constitute a Sanchalana Samiti, *Vibhag karya karini*, Zilla Karya Karinees, Prabandha Karinees or any such constituent to perform and fulfill its objects.
- i) **Palaka Mandali:** Palaka Mandali means the *supreme* authority controlling, guiding, promoting and it is the highest decision making body *of the Peetham*.
- ii) **Sanchalana Samithi:** Sanchalana Samithi means the body established by the Palaka Mandali to manage and supervise the activities of the Peetham under the Supervision of the Palaka Mandali.
- iii) **Vibhag karyakarini :-** Would be nominated by the palaka mandali for organizing and monitoring the activities taken up by the peetham in the specified geographical area of Vibhag.
- iv) **Zilla Karyakarini:** Zilla Karyakarini means the body nominated by Palaka Mandali to carry out the objectives of the Peetham in the district.
- v) **Prabandha karini:** Prabandha karini means body of organization nominated by the Palaka Mandali for each of the local schools *run by the Peetham*.

2. MEMBERSHIP

- a) The Peetham may admit any citizen of Bharat who subscribes to the aims and objects of the association as member of Peetham on payment of the admission fee and or annual subscription as fixed by the Peetham from time to time. However the Payments of such fee is not a pre requisite before nominating a member to any of the body's defined above Niyamaka Sadasyulu need not pay any fee towards membership.
- b) A person ceases to be a member of the Peetham by death, insolvency, lunacy, resignation or expulsion or *convicted for any offence of moral turpitude* any other legal disability.

3. PALAKA MANDALI

- a) The Palaka Mandali hereinafter referred to as P.M. shall be the supreme body for decision making, controlling, guiding and promoting body of the Peetham. It consists of the first signatories of the Memorandum of Association and all those later admitted from time to time, as need be. However the total number of members of Palaka Mandali shall not exceed 15.
All office bearers of Vidyabharathi and Dakshina Madhya Kshetra office bearers are also invitees to guide the Palakamandali without any voting right.
- aa) The term of members of Palaka Mandali is for six years and 1/3 members will retire on every two years and the first two batches retiring by lots drawn as decided in the meeting of Palaka Mandali. However retiring member is eligible for the renomination made by President in consultation with Organizing Secretary.
- b) In case of death, resignation or expulsion of any member of Palaka Mandali, the vacancy shall be filled up by the remaining members of the Palaka Mandali from out of the members of the Peetham, for the un expired period and in case of retirement for the full term of 6 years.
- c) The Palaka Mandali may expel any member by 2/3 majority of its total members.
- d) Powers and Functions of Palaka Mandali :
- i) It shall devise plans and programs to achieve the objects of the Peetham and it shall coordinate the working of the Prabandha Karinees, Zilla Karya Karinees *Vibhag karyakarninees* and Sanchalana Samiti. It shall form committees or subcommittees to undertake specific projects, programs and activities whenever necessary. It can also supercede the committees if necessary.
- ii) It may acquire, hold, dispose off properties movable and immovable in the name of the Peetham to achieve the aims and objects of the Peetham. All such properties acquired, purchased or otherwise possessed by or for the Peetham, shall vest with *Sri Saraswathi Vidyapeetham*.
- iii) It shall have full powers and authority to do all acts which may be necessary or expedient for achieving the objects of the Peetham.
- iv) The decisions of Palaka Mandali shall be final and binding on all the constituents of the Peetham.
- v) It shall get the accounts of the Peetham and its constituents audited by appointing auditors and get it ratified by the Sadharana Sabha.
- vi) It shall periodically review the activities of all the constituents of the Peetham and advise as necessary for better implementation of aims and objects of the Peetham.



- vii) The Palaka Mandali shall be competent to affiliate any other association or organization with objects and aims similar to those of the Peetham and also to get Vidya Peetham affiliated to Vidyabharathi Akhilabharatheeya Shikshasamsthan New Delhi or any other similar organization.
- viii) It shall meet at least twice in an year preferably in the months of January and June and as decided by the Palakamandali.
- ix) It may carry on all its undertakings through the Sanchalana Samiti or any other body constituted for a particular purpose.
- x) It may nominate one person as Vidya Peetham Pratinidhi for each *Vibhag* / Zilla or a smaller specified area. The person so nominated for a Zilla / *Vibhag* may attend the meeting of respective karyakarinee of the said areas and discharge such of the functions assigned by the Palakamandali.
- xi) To take up vocational *and skill development* training programmes for the needy sections of the people more particularly for the schedule caste and schedule tribe and economically back ward classes.
- xii) To motivate and also take up programs for all-round development of the personality i.e., physical mental, intellectual, emotional, moral and spiritual development of the younger generations in particular and the society in general.
- xiii) To organize health awareness programmes and health camps for young generations in-particular and society in general
- xiv) To conduct awareness camps and to train the younger generation for conservation of natural resources and to protect the environment.
- xv) To establish educational research institutions so as to improve the *quality of the* faculty.
- xvi) To identify and establish training centers for cottage industry handicrafts and other allied activities and to impart training to the needy.
- xvii) To undertake schemes and to take steps for the *betterment* of the weaker sections of the society.
- xviii) To take up schemes for providing adult education for the benefit of the people in general and socially deprived *in particular.*

e) The Palaka Mandali shall have the following Office-bearers.

- i) President
- ii) Working President
- iii) Vice-President
- iv) Organizing Secretary
(Organizing Secretary to be nominated by Vidya Bharathi Akhila Bharatiya Siksha Samsthan, New Delhi, from time to time, to which Peetham is affiliated.)
- v) Secretary
- vi) Joint Secretary
- vii) Treasurer

ee) The Palaka Mandali shall elect one out of them as president once in three years.

eee) The president shall nominate in consultation with Organizing Secretary the following Office-bearers for a period of three years.

- i) Working President
- ii) Vice-President
- iii) Secretary
- iv) Joint Secretary
- v) Treasurer

POWERS, FUNCTIONS AND RESPONSIBILITIES OF THE OFFICE BEARERS

President

i) He shall preside over the meetings of the Palaka Mandali. In his absence the Working President will preside. In the absence of both, the Vice-President will preside. In the absence of all the three, the members shall elect any one among those present in the meeting to preside over such meeting.

i(a) The President shall have power to nominate the office-bearers of the Palaka Mandali for the following offices i.e., Working President, Vice-President, Secretary, Joint Secretary, Treasurer in consultation with the Organizing Secretary.

ii) He will also be the President of the Sanchalana Samiti and shall preside over the meetings of the Sanchalana Samiti.

iii) The President may call an extraordinary meeting of Palaka Mandali with a short notice of three days through telephonic / mail. For Sanchalana Samiti and the General Body of the Peetham by giving a fortnight notice. The notice may be given through publication in any of the news papers published in local language or through under certificate of posting, or mail.

iv) The President shall have a casting vote.

- v) The President shall have powers of general supervision and control over all the organizational matters including employees of the Peetham.

g) Working President :

He shall discharge the functions of the President in his absence or such functions especially entrusted to him by the President in his absence or such functions especially entrusted to him by the President in consultation with the Palaka Mandali.

h) Vice President:

In the absence of both President and Working President, the Vice President shall preside over the meetings.

i) Organizing Secretary :

- i) The Organizing Secretary of the Peetham shall be the co-ordinating, guiding and motivating force of the Peetham.

- ii) He shall assist every activity of the organization in its proper functioning and he shall work as a motivating force for all the projects, programmes and activities of the Peetham.

- iii) He may attend any meeting of the various constituents of the Peetham.

- iv) He may choose and take up for himself any activity of the Peetham subject to the ratification of Palaka Mandali and carry it on.

- v) He shall act as liaison between various constituents and Palaka Mandali and also between the Peetham and all organizations with which the Peetham has affiliation.

j) Secretary :

- i) The Secretary shall be the Chief Executive of the Peetham and functions under the guidance of Palaka Mandali and in consultation with the Organizing Secretary.

- ii) He shall prepare the agenda for the meetings of Palaka Mandali as well as Sanchalana Samithi and shall cause the service of notice of such meetings on members as per bye-laws and he shall also maintain the minutes of the meetings.


- iii) He shall prepare and submit yearly balance-sheet first to the Palaka Mandali and then shall present the same in the General Body meeting. He shall also prepare the yearly budget and after obtaining clearance from P.M, place the same before the General Body for approval.

- iv) He shall be the correspondent until otherwise provided by the Palaka Mandali.

- v) He shall implement all the decisions of Palaka Mandali..

vi) He shall have over all control of the Peetham subject to the decisions of *Palakamandali*.

vii) The Secretary shall represent and act on behalf of Palaka Mandali.

viii) The Secretary shall sue and be sued on behalf of the Peetham.

k) Joint Secretary:

He shall assist the Secretary in conducting the affairs of the Peetham and also to discharge such functions specifically entrusted to him by President.

l) Treasurer :

i) He shall maintain or cause to maintain the accounts of the Peetham and shall keep or cause to keep the accounts and records in safe custody.

ii) He shall receive and deposit funds in any authorized Bank or as decided by the P.M. at its convenience at different places as per requirement.

iii) The Bank account shall be run jointly by any two out of the three, President, Secretary and Treasurer..

iv) He shall also get audited the accounts of the Peetham and its constituents by any authorized auditor as decided by the P.M.

v) He shall keep an amount of Rs. 20,000 with him as imprest amount.

4. SANCHALANA SAMITI:

A) There shall be a Sanchalana Samiti (S.S.) to manage and supervise the activities of the peetham, under the guidance and supervision of P.M. It shall be constituted once in three years as given below:

Office bearers of Palaka Mandali, All Secretaries of Zilla, *Vibhag* karyakarinees, Three Members elected by permanent teaching staff of Vidya Peetham who complete five years of service, Subject Experts 19 members, 7 more Educationists. The total number of members shall not Exceed 75.

B) The S.S may recommend to P.M. for expulsion of any of its members for indiscipline or such acts detrimental or not conducive to the aims and *objectives* of the Peetham, by majority of its members present. On that recommendation, The P.M. shall take the decision by giving reasonable opportunity to the member.

C) **Functions of Sanchalana Samiti :**

- i) *It shall recommend for establishing Sisu Mandirs and other educational institutions to the Palakamandali.*
 - ii) It shall prepare a code of conduct for the teaching staff and other employees working in the institutions governed by the Peetham and shall place them before P.M. for approval.
 - iii) It shall frame, revise and amend such rules for the smooth running of the activities of Peetham including rules for scales of pay as per qualifications for each category of employees and also frame service rules for them and place them before the P.M. for approval.
 - iv) It shall prepare syllabus for all its institutions.
 - v) It shall guide, advise and assist Zilla and *Vibhag* Karya Karinees and Prabandha Karinees in proper discharge of their functions.
 - vi) It shall *recommend to Palakamandali for constitution of committees and subcommunities* to work out and carry on activities of the Peetham such as selection of teachers, preparation of syllabus, training of teachers etc.
 - vii) Omitted
 - viii) The Sanchalana Samithi shall have power to frame rules and regulations as it thinks fit for the running, supervision and administration of Samlagna and Nirdeshita institutions and organizations.
 - ix) Omitted
 - x) The Sanchalana Samiti at its discretion subject to the Memorandum of Understanding, disaffiliate and stop guidance to the institutions, organizations affiliated or under taken to guide if it feels that the same is not feasible and practicable. The decision of the Sanchalana Samithi in this regard is final.
- D) i) The president, Working President, Secretary and Organizing Secretary of the P.M. shall hold the same office in the Sanchalana Samiti also.

5. PRABANDHA KARINEE:

- A) i) There shall be a Prabandha Karini consisting of nine members for each Sisu Mandir and other institutions established or run or controlled by the Peetham and it shall be constituted once in three years. It shall be constituted *by Palaka Mandali*.

- iii) *The Palakamandali shall nominate a Prabhandakarinee and its office bearers for each of the schools run by it. In respect of the schools affiliated to the Vidya peetham, the Prabandha karinee for each of such schools shall be nominated by school samithi (Which is Registered Society) in consultation with Vidyapeetham.*

Explanation : The Head master of the school shall be the ex-officio member of the concerned Prabandha karini.

B) Powers and Functions of Prabandha Karinees:

- i) The Prabandha Karinee shall manage the Sisu Mandir concerned effectively and in accordance with the directions of the Zilla Karya Karinee.

ii) *The prabandhakarinee make temporary appointments of teachers or other staff in case of emergency and get them approved by the SS sending the proposal through the zilla secretary.*

iii) The Prabandha Karinee may collect funds for the management and improvement of the Sisu Mandir with the approval of the Peetham.

iv) *The Prabandha karinee shall hold a meeting of the respective Sisu Mandir once in a month to review and execute the plans and programmes for development of the respective schools.*

v) *The Prabandhakarinee shall have powers to supervise the working of teachers and other staff.*

vi) Omitted.

C) President:

He shall preside over the meeting of the Prabandha Karini over such meetings.

D) Vice – President:

He will assist the President in discharge of his duties and shall preside over the meetings of the Prabandha Karini in the absence of the President. In the absence of both the members shall elect one among them to preside over the meeting.

E) Secretary:

- i) He shall prepare the agenda for every meeting of the **Prabandha Karini** and shall convene the meeting of **Prabandha Karini** with a clear notice of 3 days.
- ii) He shall maintain the minutes of the meetings of **Prabandha Karini**.
- iii) He shall manage the funds of the Sisu Mandir and supervise the accounts of the Sisu Mandir.
- iv) He shall implement the decisions of the **Prabandha Karini** in accordance with the guide lines laid down by the Peetham.
- v) He shall correspond on behalf of the **Prabandha Karini**.
- vi) He shall implement the decisions of the **Prabandha Karini** in accordance with the guidelines laid down by the Peetham.

F) Joint Secretary:

He shall assist the Secretary in the discharge of his duties when ever necessary and may be entrusted with such responsibilities as decided by the **Prabandha Karini**.

G) Treasurer:

- i) He shall maintain accounts and keep the records of accounts in safe custody.
- ii) He shall keep the funds of the Sisu Mandir in any authorized Bank and operate with the signature of Pradhanacharya, countersigned by the Secretary or Treasurer.

H) The Tenure of Office:

The Tenure of Office-bearers of Prabandha karinee shall be for 3 years. And they shall continue till the new body is nominated by competent authority. The Peetham may nominate the person for discharging the functions of the Prabandha karinee till the new body is nominated.







- ii) He shall have a casting vote.
- iii) In his absence, the Vice President shall preside over the meetings. In the Absence of both, any member elected from amongst those present will preside.





7. SADHARANA SABHA (GENERAL BODY) :

All members of Palaka Mandali, Sanchalan Samithi, All Presidents of *Vihhag and Zilla* Karyakarinees, *X-Presidents of Vidyapeetham and members* admitted by the Peetham from time to time.

- i) The General Body shall be called once in a year *preferable after finalisation of annual accounts or as decided by Peetham.*

8. AMENDMENT TO THE RULES:



9. FUNDS OF THE PEETHAM:

- a) The subscriptions and donations collected by the Peetham shall form the funds of the Peetham. These funds shall be spent for achieving the objects of the Peetham and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any members.
- aa) All funds thus collected shall be deposited in any Nationalized Bank *or sponsored by Nationalized Banks* and it shall be operated by the President, Secretary, Treasurer of the Peetham with the joint signature of any two.
- b) The *Peetham* shall maintain a Reserve Fund in the Bank into which, 1/5 of surplus if any, under the annual balance sheet, shall be deposited every year.

The corpus of such Reserve Fund shall not be touched except for capital investment approved by the P.M. The interest on such deposit shall, however, be available for the running expenses of the Peetham.

- c) All funds collected in any form in the name of the peetham shall form the funds of the peetham and the Peetham may provide such amounts to each prabandhakarinis. Zilla / *Vihhag* Karya Karini or other wise use such funds as is necessary to achieve the objectives of the Peetham.
